9. Guest speaker

John introduced the guest speaker Lauren McQueen, Volunteer Programs Manager, ACT Parks and Conservation Service. Lauren spoke about her background in volunteer management, and her experience in the PCS since joining in November 2021. She outlined her responsibilities in managing the four streams of volunteers in the PCS and her current work in reviewing the policies and insurance arrangements for the volunteer streams. Lauren stressed the importance of advocating upwards for volunteers and mentioned recent work for the Annual Report that calculated the value of the efforts of PCS volunteers at \$1.5 million for the year.

In response to questions from the floor, Lauren talked about her experiences in talking to volunteers and visiting ParkCare sites to better understand volunteer needs.

There was also some discussion around the method used in calculating the dollar value of volunteer efforts and improving how this data was collected.

John thanked Lauren for her speech and the meeting showed its appreciation in the usual way.
